1. Vision Statement:

At Northwood Primary School we endeavour to make reasonable adjustments to reduce and eliminate barriers that impair access to the curriculum, thus enabling everyone to participate in the life of the school community, including pupils, staff and visitors with a disability. The school aims to work closely with disabled pupils, their families and any relevant outside agencies in order to allow them to learn, achieve and participate fully in school life. The school is active in promoting positive attitudes to disable people in the school and in planning to increase access to education for all disabled pupils.

This policy is drawn up in accordance with Schedule 10 of the Equality Act 2010 and schedule 10 – accessibility for disabled pupils. The effect of the law is the same as in the past, meaning that "schools cannot unlawfully discriminate against pupils because of sex, race, disability, religion or belief and sexual orientation."

Principles

In performing their duties, governors and staff will have regard to the DRC Code of Practice (2002).

- Not to treat disabled students less favourably for a reason related to their disability;
- To make reasonable adjustments for disabled students so that they are not at a substantial disadvantage;
- To plan to increase access to education for disabled students.

Definition of Disability

According to the Disability Discrimination Act 1995 (DDA) and subsequently by the Equality Act 2010 disability is defined by the as:

"A person has a disability if he or she has a physical or mental impairment that has a substantial and long-term adverse effect on his or her ability to carry out normal day-to-day activities".

2. What will the Accessibility Plan do?

- 1. The Accessibility Plan is structured to complement and support the school's SEN Policy, which can be accessed via our website.
- 2. Northwood Primary School is committed to providing an environment that enables full curriculum access that values and includes all pupils, staff, parents and visitors regardless of their educational, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to taking positive action in the spirit of the Equality Act 2010 regarding disability and to developing a culture of inclusion, support and awareness within the school.
- 3. The Northwood Primary School Accessibility Plan shows how access is to be improved for disabled pupils, staff and visitors to the school within a given timeframe and anticipating the need to make reasonable adjustments to accommodate their needs where practicable. The Accessibility Plan contains relevant and timely actions to:
 - Increase access to the curriculum for pupils with a disability, expanding the curriculum as necessary to ensure that pupils with a disability are as prepared for life as their ablebodied peers. This encompasses teaching and learning and the wider curriculum of the school such as participation in, leisure and cultural activities, extracurricular activities or school visits. It also covers the provision of specialist equipment, which may assist these pupils in accessing the curriculum within a reasonable timeframe.
 - Improve and maintain access to the physical environment of the school, adding specialist facilities as necessary this covers improvements to the physical environment of the school and physical aids to access education within a reasonable timeframe.
 - Improve the delivery of written information to pupils, staff, parents and visitors with disabilities; examples might include hand-outs, timetables, textbooks and information about the school and school events; the information should be made available in various preferred formats within a reasonable timeframe.
- 4. Whole school training will recognize the need to continue raising awareness of equality issues for staff and governors to comply fully with the Equality Act 2010.
- 5. This Accessibility Plan should be read in conjunction with the following policies, strategies and documents:

- 6. The Accessibility Plan will be published on the school website.
- 7. The Accessibility Plan will be monitored by the Senior Leadership Team.

3. Our Aims

The school will ensure that the accessibility of provision for all pupils, staff and visitors to the school is paramount. The main priorities in the school's plan will be in the following areas:

- Increasing the extent to which disabled pupils can participate in the school curriculum
- Improving the physical environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services
- Improving the delivery of information to disabled pupils, staff, parents and visitors in an appropriate format

Our objectives are detailed in the Action Plan below.

4. Current Good Practice

We aim to ask about any disability or health condition in early communications with new parents and carers. For parents and carers of children already at the school, we collect information on disability as part of our ongoing discussions and we have an open and genuine relationship with our parents. Children with disabilities may in some cases require a care plan.

Physical Environment

Disabled pupils are offered opportunities to partake in extra-curricular activities. Some aspects of extracurricular activities present particular challenges, for example: lunch and break times for pupils with social/interaction impairments, after-school clubs for pupils with physical impairments, school trips for pupils with medical needs. There are no parts of the building which children or adults with disabilities cannot access.

Curriculum

There are few areas of the curriculum to which disabled pupils have limited or no access. Some areas of the curriculum present particular challenges, for example: PE for pupils with a physical impairment, science and technology for pupils with a visual impairment. Other issues affect the participation of disabled pupils, for example: bullying, peer relationships, policies on the administration of medicines, the provision of personal care, the presence or lack of role models or images of disabled people, in effect, all the school's policies and procedures, written and unwritten. We are a communication friendly environment and key staff are trained in a variety of communication ways. We have a Speech and language Therapist on site due to our Enhanced Mainstream Provision for children with Speech Language and Communication needs. Outdoor learning is an integral part of the curriculum for pupils at Northwood Primary School and children

with disabilities are able to fully access all areas of the outdoor environment. Inclusion is at the heart of our practice.

Information

Different forms of communication are made available to enable all disabled pupils to express their views and to hear the views of others if required. Access to information is planned, with a range of different formats made available for disabled pupils, parents and staff if required.

5. Audit of current practice and provision

- A lift is in place for easy access to the first floor.
- The school has 3 disabled toilets that are sufficiently large enough to accommodate a wheelchair and toileting chairs / steps.
- Electronic Whiteboards, Redcat Soundfield systems and visualisers are in place in all classrooms, supporting the learning of ASD, VI and HI pupils and those with moderate learning difficulties.
- The school has introduced cursive script handwriting to support the development of effective writing skills.
- The SENCo attends regular Inclusion Network meetings with the Local Authority and Multi Academy Trust per year to keep abreast of current issues.
- Pupils with visual dyslexia are provided with coloured overlays and resources to meet their needs.
- Some children with specific needs have additional adult support to enable them to access the curriculum.
- Fire exits from the upper floor have outdoor hand rails and high visibility paint on each step.
- Staff are trained in interventions to support children with physical and sensory difficulties.

6. Management, coordination and implementation

- We will consult with experts when new situations regarding pupils with disabilities are experienced.
- The Governors and Senior Leadership Team will work closely with the Local Authority and the Trust.

It is a requirement that the school's accessibility plan is resourced, implemented and reviewed and revised as necessary. Attached is a set of action plans showing how the school will address the priorities identified. This Action Plan will be reviewed annually as part of the ongoing budget planning cycle.
